**Special Elector Meeting Minutes  
October 21, 2019, at the Rockland Town Hall  
Called to order by Chairman Cashman at 6:55 p.m.  
Adjourned at 7:06 p.m.**

The Clerk, Treasurer, and all Town Board members were present. Also present were Bob Gerbers, Terry Vertz, and Tom Collins from the Wrightstown Spirit. Arriving mid meeting were John & Michelle Kahl.

The Chairman called the meeting to order at 6:55 p.m. Chairman read the Special Town Meeting of Elector's Notice and Agenda. Clerk Koenig verified that it was properly noticed.

**Use of the Carryover Levy Capacity**

The Clerk explained the levy limit worksheet and that there is the option to use a carry-over tax levy capacity under statute 66.0602 (3)(f). The amount for Rockland would be \$794. The Town Board authorized this with Resolution 2019-02. The Clerk asked the electorate if they would also vote to approve the use of those funds. M/M by Terry Vertz to use the carry-over levy capacity for the 2019 tax levy funding the 2020 Town Operating budget. Seconded by Bob Gerbers. Motion carried. Ayes = 6, Nay – 0, Abstaining = 0.

**Adoption of Resolution #2019-04 Elector's Approval to Endorse the Town Board's Resolution to Exceed the Levy**

Chairman Cashman explained that the tax levy for 2019 to be collected in 2020 would be \$497,495, which would be short approximately \$50,000 due to the increases in protection services. At the preceding budget hearing, the town board shared that an increase of \$50,000 would support the board in keeping services constant. The board proposed to exceed the levy limit with Resolution 2019-03.

M/M by Bob Gerbers to approve Resolution #2019-04, which approves the endorsement of the Town Board's resolution to exceed the allowable levy for 2019 by \$50,000, to be collected in 2020, in the amount of \$547,495; seconded by Terry Vertz. Motion passed by hand vote: Ayes= 6; Nays= 0; Abstaining= 0.

**Electors' Adoption of the Town Tax Levy**

Chairman Cashman explained that the tax levy for 2019 to be collected in 2020 would be \$ 547,495. The mill rate would be 2.6451974255 per \$1,000.00.

M/M by Terry Vertz to approve Resolution #2016-09, which adopts the tax levy for 2019 to be collected in 2020, in the amount of \$547,495; seconded by Bob Gerbers. Motion passed by hand vote: Ayes= 6; Nays= 0; Abstaining= 0.

**Adjournment**

M/M by Terry Vertz to adjourn the meeting at 7:03 p.m.; seconded by Bob Gerbers. Motion passed unanimously by voice vote.
