## A Note from the Chairman,

On March 24<sup>th</sup> our temporary spring weight limits will go into effect on all Town roads. The weight limits will be left on until the roads are free of frost. Hello Rockland Residents,

Yes, it is true; spring will soon be here. Because it's been such a cold and snowy winter, as soon as possible, many of us will be walking and biking our town roads. Please be watchful. We all want to enjoy our warmer weather.

With the coming of spring, your Town Board prepares for our Annual Meeting which will be April 15, 2014 at 7:30 pm at the Rockland Town Hall.

### **FINANCIAL REVIEW**

To prepare for our annual meeting, one of the items your Town Board must take care of is the review of our financial records. This process includes the reconciliation of the Treasurer's (Mary Van Dyck) records with the Town Clerk's (Jann Charette) financial records. Because we have a Treasurer and a Town Clerk, we do not need an outside audit of the books.

Once the records are reconciled between Mary and Jann, then at a Town Board review meeting, we review each of their records with the town's bank statements and then approve the financial statements. These approved financial statements are the basis of our Annual Report.

### **ANNUAL TOWN MEETING**

The annual town meeting is a meeting of the town's electors. A qualified elector is someone eligible to vote in the town; but does not need to be a registered voter. A qualified elector is a U.S. citizen at least 18 years old and a resident of the town for at least 28 consecutive days prior to the annual town meeting.

Any qualified elector present may make or second motions; participate in the discussion of a matter and vote. The annual town meeting is not a town board meeting. Town officials are generally just electors like everyone else at the annual town meeting.

All actions are decided by a majority of the electors present and voting. The chair of the town board (Dennis Cashman) is also the chair of the annual meeting. The town clerk is also the clerk of the annual town meeting.

The agenda for our annual meeting will be on our website: [TownofRockland.org](http://TownofRockland.org) and also posted at the Town Hall, Just Stop Inn, and Scray's Cheese. Any agenda items requiring a vote are voted on by all the electors present at the meeting.

Please join us for our annual meeting, Tuesday, April 15, 2014 at 7:30 pm at the Rockland Town Hall.

Hello, everyone.

Spring is coming slow but that's a good thing since a fast snow-melt would certainly cause some flooding situations in Rockland. One thing to watch is where someone may have piled snow in the road right-of-way ditches. Since the additional snow will not be melted away as soon as the snow in the rest of the area, it may cause obstruction to proper drainage and cause upstream flooding. Note: It is against state law for anyone to put an obstruction in a road or a road ditch. This includes pushing snow from your driveway across the road to the other side.

The state legislature has been busy. Fortunately, the bill on nonmetallic mining, which includes sand and gravel pits, is dead. This bill would have preempted local governments from adopting environmental regulations for such projects which includes dust control, road damage, etc.

There has been a lot of work done on a bill in regard to "implements of husbandry" which are all the pieces of machinery and equipment used for agricultural purposes but not trucks or truck tractors which are commercial vehicles. The issue has been the use of roads by these implements. They have grown in size and weight over the years causing damage and deterioration to roads, especially town roads. Over a dozen associations have been working out a compromise with the legislators. The final bill attempts to accommodate reasonable use of the roads by these implements while still providing local governments the ability to minimize impacts on their roads. At this reading, the legislature has not voted on this bill.

One bill, passed by the Senate and still waiting for the Assembly to act, extends the current law to provide immunity from civil liability related to noise or nuisance complaints for sport shooting ranges besides the protection they have now from zoning actions. It also provides immunity from civil liability for damages from the shooting activities on the range's own property.

Changing the subject: in our last newsletter, I reported on the progress for upgrading our traffic signs. Chairman Cashman has ordered and received the 70-plus signs. As soon as weather permits, activity will begin on the replacements.

## **News from Treasurer Mary Van Dyck**

I just completed the annual recycling accomplishments and costs for the State of Wisconsin. Our recyclables go to the BOW (Brown, Outagamie, Winnebago) recycling center. The Town of Rockland had a total of 163.24 ton of recycling material in 2013. This means that every resident in the Town of Rockland recycled about 187 pounds of material. This is a very good amount per person. Keep up the good work We received a grant in the amount of \$2,872.13 to put toward our recycling program.

### **DOG LICENSES**

Remember dog licenses are due by April 1. A dog license is required for all dogs who are 4 months of age or older. Vaccinations against rabies are required, Section 95.21(2) within 30 days after the dog reaches 4 months of age and shall be repeated within one year after the initial vaccination. In addition, dogs shall be revaccinated when their rabies certificate expires. A certificate documenting that the dog's rabies vaccinations are current shall be presented when applying for the dog license. ### **PET CLINIC**

The Town of Rockland will hold a pet vaccination clinic for all dogs and cats residing in the Town of Rockland on Saturday, April 12 from 10 a.m. to noon. Rockland pet owners are encouraged to bring their dogs and cats to the Rockland Town Hall to get their vaccinations up to date. Dr. Janssen will be administering rabies, distemper, lyme, and bordatella vaccinations. You do not need an appointment. Please have your pet on a leash or in a cage. There will be a fee for his services. Thank you Dr. Janssen for offering this pet clinic to the Town of Rockland residents!

**Happy Spring Everyone!**

I hope this finds you well and excited for Spring! Soon enough the trees will be budding, the garden and crops will be planted, the flowers will be blooming, the grass will be growing, and the Fox River trail will be free of snow and ready to trekked on again. As we transition into this Spring season, I hope that you get a chance to reflect on and enjoy the beauty that surrounds you in the Town of Rockland. It really is a lovely place to live! All of us here, would like to keep Rockland that way. So, here are a few events to help us keep Rockland looking clean and beautiful:

- 1) As Chairman Cashman stated, the Rockland Clean Up day is Saturday, April 19th. Please take the time to peruse your properties, especially your ditches, and remove any litter and excess garbage.
- 2) In cooperation with Cyber Green and the Rockland 4H group, we will host a community-wide Electronics Recycling Day on Saturday, May 3, 2014, at the Rockland Town Hall from 8 a.m. to noon. Some electronics are free to recycle. Others such as monitors, TV's and console TV's are charged a fee to recycle. We are currently creating a flyer with all of the important details and will have this available at the Annual Town meeting and on our new townofrockland.org website in mid April.

#### **SPRING GENERAL ELECTION– TUESDAY, APRIL 1, 2014**

With Spring, also comes the Spring General Election scheduled for Tuesday, April 1, 2014. I have printed the sample ballots for you to review on the insert enclosed. (They also can be viewed on the townofrockland.org website). As you can see, the ballots look a little different. That is because each municipality in Brown County is now required to use the DS-200 Precinct Ballot Scanner. Instead of “completing the arrow” to the right of the candidate’s name, you will be “filling in an oval” to the left of the candidate’s name. When you have completed your ballot, you will enter it into the DS-200 machine that has a computer screen on it. If the ballot is completed correctly and entered into the machine properly, the screen will state “You are finished. Thank you for voting.” Please do not leave the voting area until you have received that message. All of our election workers have been trained on the new equipment. So if you have any questions on this new process, we would be happy to answer them for you on Election Day.

#### **ANNUAL TOWN MEETING, TUESDAY, APRIL 15, 2014**

As Chairman Cashman and Supervisor Van Vonderen mentioned, our Annual Town meeting is Tuesday, April 15, 2014, at 7:30 p.m. at the Rockland Town Hall. One of the items discussed during this meeting is the Annual Report. You can obtain a copy of this report at the town hall on Election Day or by going online to the townofrockland.org website after April 1st. We will be launching the rebuilt website at the Annual Town meeting. So I hope you will attend.

#### **OPEN BOOK/BOARD OF REVIEW**

The Open Book review will take place from 2-4 p.m. on Thursday, May 1, 2014 at the Rockland Town Hall. You can meet with Bob Taicher, Assessor, 863-6454, during this time to discuss your property’s assessed value. The Board of Review will meet on Tuesday, May 13, 2014 from 6 p.m. to 8 p.m. to review the Town’s assessment rolls and to hear any written objections/appeals made by property owners. Pertinent forms and guidance documents for the Board of Review will be available on the new website after April 15th.

## **ROCKLAND FIRE ADDRESS SIGN SUBCOMMITTEE UPDATE**

The Town's Fire Address Sign subcommittee has completed its work and submitted a Federal Emergency Management Agency (FEMA) Fire Protection and Safety (FP&S) grant on March 21, 2014. We won't know if FEMA will approve our grant application until they start awarding the grants between May 1, 2014 and August 31, 2014.

If our FEMA grant is approved the Town plans on: 1) Purchasing and installing highly reflective emergency address signs this summer at all 698 properties in the Town and 2) Purchasing and installing smoke detectors and CO detectors starting this summer in all 629 homes in the Town.

The subcommittee would like to thank the Town's mutual aid agencies for their support, information, and guidance in assisting us in preparing the grant application. The Morrison and Greenleaf Volunteer Fire Departments, County Rescue, Brown County Sheriff Department, and the Brown County 911 Communications Center were all instrumental in providing key pieces of information and experience. In addition to those mutual aid agencies we'd also like to thank De Pere True Value Hardware, Country Visions Cooperative, the Emergency Room departments at Aurora Bay Care Medical Center and Bellin Memorial Hospitals, the Unified School District of De Pere, the Wrightstown Community School District, Wisconsin Public Service, the City of Appleton Fire Department, the City of De Pere Fire & Rescue Department, Northeast Wisconsin Technical College (NWTC), and Fox Valley Technical College (FVTC) for their help.

We'll let you know as soon as we hear from FEMA if our grant application is approved.
