This fall we will be removing dead trees from the right of way on certain town roads. The cutting of these trees will eliminate emergency cutting at night or in storms when these trees break and tip over.

We will also be cutting ditch vegetation to the backside of the ditches where possible. This process removes grass and brush and keeps the ditches clean for water flow.

In my opinion, the best time of the year is upon us— the fall season. Days are cooler, trees are turning vibrant colors, hunting season starts and it's harvest time for farmers. Farmers will work day and night harvesting their crops, hauling out manure and tilling their fields. Please be patient with farm equipment on our roads for the next couple of months.

News from Treasurer Mary Van Dyck

Summer has come and gone. I hope everyone had time to rest and relax a little. Recycling and garbage is going good for the Town of Rockland. I am applying for a grant again this year. The Town has gotten this grant for several years. This year our grant was for \$2,409.00. This is used to help pay for the recycling pick up. In order to apply for the grant, we must be in compliance with state weights. These weights are what the state says each person must recycle in a year. So far the Town has always been above the required weights per person. Keep recycling.



I will have dog licenses for 2020 available by November 1, 2020. The fees are \$5.00 for a neutered or spayed dog and \$10.00 for a dog that is not neutered or spayed. The application will be in the December newsletter. It will also be posted on the website. Remember all dogs must be licensed. This is a state law.


Just an early reminder that your tax bills will be mailed to you around December 8. When you get your bill, make sure you look for the lottery credit. You are eligible for the lottery credit if this is your primary residence and you do not claim the lottery credit on another property. You also must have lived in the residence on January 1, 2019.

Last year I went through our Town bills and found several did not have the lottery credit on them. It was mostly new homes in our Town. It is your responsibility to apply for the lottery credit. If you have questions regarding the lottery credit or your tax bill, do not hesitate to call me. I will try to answer your questions or get you to the proper person for help.

Watch for buses and remember you must stop when the bus has flashing red lights on. You must stop behind the bus as well as coming toward the bus. Please keep our children safe. Have a wonderful fall.

Hello Rockland residents,


Another summer has come to a close and we will soon see the fall colors. I feel fortunate to live where we get to experience all the seasons and the joys that come with each one.

What a nasty couple of weeks this has been, weather-wise. Hope you are all ok. As I write this letter on Sept 11th, my rain gauge shows more than 2 and a half inches of rain in one day; not to mention the three inches a few weeks earlier. Water everywhere. If you see problems with a road or culvert please give one of us a call.

This may be old news, but that huge wind storm did some serious damage in isolated areas in Rockland. Electricity was off for a couple of days; everyone was scrambling to find generators. You may not know it but my neighbor John Van Noie, lost a barn. It had to be a isolated tornado. The wind blew half of the entire roof up and over the 2 story farm house never touching it and landed it in a field 200 yards away. Many folks lost trees. Just south of Lasee Road, trees were twisted off 10 and 15 feet off the ground. Enough about weather.

Your town board is working on several issues and one is to draft an ordinance to allow certain off road ATV/UTVs to be on town roads. And we are asking for your thoughts, let us know. (Daytime only please). See insert.

We had planned to repair a large culvert on Old Martin Road east end, we put it out for bids and only one contractor responded. That bid was in excess of \$150,000. So we rejected that offer and will try again maybe early spring when more contractors will bid.

Our goal is for all members to participate in the Brown County Fair and we reached that goal. The experience of bringing your item(s) to the fair and being judged face to face, telling the judge how and why you picked this project to the fair, will be something to grow with in the upcoming years for schooling and for your career of choice. 
