A NOTE FROM THE CHAIRMAN

At the November 15, 2022 Special Meeting of the Electors, the electors approved the 2022 Town tax levy to be paid in 2023 of \$599,819. The town tax rate will be \$2.75 per \$1000 of valuation. I'm pleased to say this is the same rate as last year. I would like to thank the entire Town Board for working together to keep expenses under check.

Back in May of 2020 we applied for a grant from the WIS DOT to resurface Midway Road between Hwy 57 and CTH PP. The 2 mile stretch of roadway would be resurfaced with 4 inches of hot mix asphalt pavement and add gravel shoulders. The DOT accepted our project as one of 84 town projects accepted across the state and one of only two projects in Brown County. The Multimodal Local Supplement program will reimburse us \$381,197 in road costs. The project is in the final stages of completion. At our October Town Board meeting, we also lowered the speed limit on that section of road from 45 MPH to 35 MPH. New signs will go up in December.

With the snow season already here, remember not to plow snow onto or leave piles on our town roads. This is a hazard to all drivers and for the plow trucks. If you have any questions or issues about snow plowing on our roads, please call me or one of the other Supervisors.

With the Holiday season upon us, I would like to wish everyone a Merry Christmas and a Happy and Healthy New Year! I hope to see you at the next Town Board meeting.



The Town of Rockland is going through the process of converting our email to dot.gov addresses. This will keep town information and correspondence more safe than ever in this age of cybersecurity concerns. We anticipate the change to occur soon. Lots of things to report since last newsletter, I'll touch on a few. The elections are over—it's safe to turn on a TV without a negative political commercial. As always Rockland voters turned out in great numbers with just over 80% having voted. We needed 33 more voters to be the number one voter turnout township in Brown County. According to Randy Hansen, Chief Election Inspector in Rockland,1,067 folks voted out of 1,319 registered voters. State wide only 57% voted. That's very sad. I'm proud that folks in Rockland value the privilege of voting.

Your Town Board adopted the 2023 budget and I'm proud of our Clerk, Treasurer and Chairman; we all worked to keep the property tax rate the same as last year. It is \$2.75 per \$1,000 of assessed value. By comparison, De Pere's rate is \$4.73 per \$1,000 and Green Bay rate is \$7.58 per \$1,000.

On November 7th, Rockland held a public hearing on a request by a dairy to build a 2 million gallon manure digester water storage pit just off Tetzlaff Road. Nearly 100 neighbors and others attended and made their feelings known to the board. I want to thank everyone for the very respectful manner in which they conducted themselves. As I stated in the meeting, when a new development is proposed, the developer needs to convince the neighbors that it's a good idea. In this case, there is no benefit to the town and it does interfere with neighbors quality of life. Ultimately the full board voted it down.

Last item, a 4-way stop sign will be installed on the corner of Ryan and Old Martin Roads by Scrays Cheese Factory.

ROCKLAND 4-H NEWS

November is the start of our holiday community service programs. We start at our monthly meeting where members made tie blankets for Christian Outreach in De Pere for donation to needy families in the De Pere area. Parents help with the cutting and the younger members do the tie of the cut strips. We made 6-8 youth size blankets. We also made name tags for the December meeting when we will package up the sugar cookie holiday cut outs. We bake, decorate and package about 75 dozen cookies to be distributed to Rockland and friends of 4-H. We make sure to make enough for grandparents and families of 4-H members – Leaders included. TAX COLLECTING FOR 2022 -2023

This year I will be collecting the taxes for the Town of Rockland. You can pay by mail, or I will be at the Town Hall from 8:30 - 4:30 on December 19, 20, 22, 27, 28, 29, or 30. I will also be at the Town Hall in January. Those dates are January 30 and January 31 from 8:30 - 4:30. I also have a box by my front door where you can drop off your payments anytime. I will mail a receipt to you for your taxes. The address to send the taxes by mail is Town of Rockland, 1712 Bob Bea Jan Road, De Pere, WI 54115. I will only be accepting checks or cash. If you want to pay with a credit card, you must do that on line. My preference is a check. Thank you.

Your tax bill should arrive around December 8. If you do not receive it by December 15, please call the County Treasurer Office at 920-448-4074 to check where it is. Every year there are bills that get lost in the mail. It is your responsibility to pay taxes on your property.

When you receive your bill, look it over. If your home in the Town of Rockland is your primary residence, make sure you have a lottery credit on the bill. It is up to you to claim the lottery credit. You only need to claim the lottery credit once. Then every year it should be on your tax bill.
