**Review and take action on Class B – Liquor & Beer – on premises renewal application from De Pere Sportsmen’s Club, 3623 Club Drive, De Pere, WI 54115**

She also requested a list of violations or citations from the Sheriff’s Department that may have been issued on the establishment over the past year – there were none. Clerk Koenig recommended that the Board renew the Class B license for the De Pere Sportsmen’s Club for the period of July 1, 2017 through June 30, 2018.
