- b) Rezone Lot 2 of Certified Survey Map, dated 6-19-2017 (“Exhibit A”), received from David Marx, Owner, Parcel R-141, 11.570 Acres in size, CTH W, De Pere, Wisconsin, Agricultural Non-Participating Working Lands Initiative (NPWLI), to Estate Residential 10-Acre District (ER-10), and
- c) Rezone Lot 3 of Certified Survey Map, dated 6-19-2017 (“Exhibit A”), received from David Marx, Owner, Parcel R-141, 3.676 Acres in size, CTH PP, De Pere, Wisconsin, Agricultural Non-Participating Working Lands Initiative (NPWLI), to Estate Residential 2-Acre District (ER-2)
